Of the fourteen (14) students enrolled in the Methodologies courses, we can point out that the scores fluctuated between 50 and 43 for an average of 90%. Five (5) students earned A's for 71%, two (2) students earned B's for 29%.

When analyzing the scores, the indicators with the highest averages were #1, #9 and #10. In indicator #4, #5 among the 14 students obtained an average of 100%. In indicator #2, #3, #6 and #7 among the 14 students they obtained 90% for indicator #8 among the 14 students they obtained an average of 92%. It is inferred that the performance of the students was outstanding.

In general, according to the results, particularly from August 2021, the excellent execution of the students is evident according to the description of the course. Likewise, according to the results of the students' execution, the objective "Reflection (TESOL 1.a.1, 1.a.2; CAEP 1.4, 1.5; INTASC 1, 4)" is mainly evident.
